NOTICE TO DEFEND

_____ You, (respondent), have been sued in court to modify

No party may make a change in the residence of any child which significantly impairs
the ability of the other party to exercise custodial rights without first complying with the
applicable provisions of 23 Pa.C.S. §5337 and P.a.R.C.P. No. 1915.17 regarding
relocation.
