# <u>LANDLORD/TENANT ARBITRATOR/MEDIATOR REQUIREMENTS & APPLICATION INSTRUCTIONS</u>

#### **Requirements:**

- 1. Be a member of the Pennsylvania Bar and be actively engaged in the practice of law in Allegheny County.
- 2. Attend a Court sanctioned training CLE: "Arbitrating and Mediating Landlord/Tenant Disputes".
- 3. Report at 9am on the date summoned and must set the entire day aside to serve.
- 4. Hear all case evidence, decide factual disputes, and legal issues prior to entering an award.
- 5. Use a court issued Chromebook to access the case file docket entries and documents electronically from the Department of Court Records website.

#### **Application Instructions:**

- 1. Complete the attached Arbitrator Application form. Note: You will be both summoned and paid at the address you list as "Business Address".
- 2. Complete a W-9 form found in the Arbitration forms section on the Civil Division's website.
  - a. List your name on line 1 NOT your firm's name
  - b. Check "individual" on line 3
  - c. Use the same "Business Address" on lines 5 and 6 you listed on your data sheet
  - d. Enter your individual Social Security Number in Part 1
  - e. Sign and date
- 3. Use the same business address on **BOTH** forms as arbitrators are paid by check.
