## **CUSTODY FILING INSTRUCTIONS: PETITION FOR CIVIL CONTEMPT**

**DISCLAIMER**: Court staff cannot provide you with legal advice. It is your decision to determine if this is the correct matter to be filed in your case. Assistance with providing forms and procedural advice is not equivalent or a replacement for advice from an attorney who represents you. The Court does not provide an attorney to represent you free of charge in a custody case. Please be advised that nothing contained in these instructions and forms should be construed as legal advice and does not guarantee that the action is correct or will be granted by the Judge.

- 1. Complete the forms.
- 2. **If you already have a custody order,** and a party is not following the custody order, attach a copy of your current custody order and complete the following attached forms:
  - Petition for Civil Contempt/Disobedience of a Custody Order
  - Remote Client Information Sheet
  - Criminal Record/Abuse History Verification Form
  - Self-Represented Litigant Form

## **PLEASE NOTE:**

For a party to be found in contempt, you must prove that they willfully disobeyed the custody order. Please be prepared to provide the specific instances (dates and times) that the custody order was not followed. You cannot request a change in custody by filing a petition for civil contempt. Also, a party cannot be found in contempt for failing to exercise *their* custody time as ordered. You cannot request that a custody order be enforced if it is not the current custody order on your case.

- **3.** You will need to comply with the requirements of the Public Access Policy.
- **4.** Take all your completed forms (unredacted original and redacted copy), along with a copy of your current custody order, to the Allegheny County Department of Court Records (DCR) at 414 Grant Street, Pittsburgh, PA 15219 to file. For information on hours of operation, go to <a href="https://www.dcr.alleghenycounty.us">www.dcr.alleghenycounty.us</a>.
- 5. You must give notice to the other party. It is your responsibility to ensure that a copy of your petition to modify, Remote Client Information Form, and Domestic Violence Waiver are served on the other party. The Court WILL NOT make service for you and your case will not be scheduled until you have proved service. For a petition for civil contempt, you may serve a copy on the other party via US regular mail. Once you have served the other party, download and complete the Certificate of Service. File this form with the DCR. If service is not completed within 30 days of the service order being issued then the petition may be dismissed.
- **6.** Once you have proven that the other party was served with your petition for civil contempt, the Court will contact you with a scheduling notice. The Court may call you from a private, blocked, or restricted phone line. The Court may send you an email, so please make sure you are

regularly checking and responding to your email. You may also receive a scheduling notice by US regular mail.

- 7. If you did not complete and file the Remote Client Information Form your case will not be scheduled until you complete it and send it to the Custody Department by email at <a href="mailto:custodydepartment@alleghenycourts.us">custodydepartment@alleghenycourts.us</a> or by mail to the Family Law Center Custody Department, 440 Ross Street, Suite 1030, Pittsburgh, PA 15219.
- **8.** If you did not provide a phone number, email address, or regular mail address for the other party, your case will not be scheduled until you contact the Court and indicate you are prepared to have the other party <u>personally served</u> with notices.
